ANTHONY DEMANGONE, Esq – Executive Vice President & COO, NAFCU

Mr. Demangone oversees day-to-day operations and manages the association's education, marketing, membership, human resources, building facilities, finance and information technology functions. He also authors NAFCU's executive blog, Musings from the CU Suite.

Before assuming the COO position, Demangone served as NAFCU's Vice President of Regulatory Compliance, where he led a staff of compliance attorneys and managed the day-to-day affairs of NAFCU's compliance assistance program.

Prior to NAFCU, Demangone's practice focused on helping clients comply with federal and state regulations in the areas of occupational safety and health, employment law, environmental law and alcoholic beverage law. He is a member of the Virginia Bar Association.

RUDY MAXA – Award Winning Travel Writer, TV Personality & Columnist

Mr. Maxa is the host and executive producer of 85 half-hour travel shows on the world's great destinations that are broadcast on public television in the U.S. with the titles Smart Travels: Europe with Rudy Maxa, and Rudy Maxa's World.

Maxa began his career in journalism as an investigative reporter, magazine writer, and personalities columnist at The Washington Post. His reporting on a Capitol Hill sex scandal and the resulting changes in congressional rules was nominated for the Pulitzer Prize, and he received the John Hancock Award for Excellence in Business and Financial Journalism for a series of stories on an international Ponzi scheme.

Maxa's career as a travel journalist started in 1990 when he began contributing bi-weekly travel commentary to the public radio business show Marketplace. He attributes his desire to travel partly to the fact he grew up as a military brat.

LARRY FAZIO – Director Office of Examination and Insurance, NCUA

Mr. Fazio joined NCUA in 1991 as an Examiner in Chicago. During his career with NCUA, Larry has served in multiple leadership positions at the NCUA including, the Director of Risk Management in the Office of Examination and Insurance (E and I), the Deputy Director of the Office of E and I, and NCUA's Deputy Executive Director. In June 2011, Larry was selected as the Director of the Office of E and I. He is responsible for providing leadership over the agency's examination and supervision program.
